1. Aghios Nikolaos Marina in Crete joins K&G Med Marinas.

K&G Med Marinas Management has undertaken the marketing management and promotion campaign of Aghios Nikolaos Marina in Crete. This is the 5th marina cooperating with K&G which meets all the criteria of a well organised marina offering high quality services.

Very shortly, the marina of Aghios Nikolaos will be offering all the medmarinas services, such as Med Marinas Club Membership and discounts on mooring fees to all MedMarinas Club members, Long Term Berth Leases, new website (www.medmarinas.com) with the option of online reservation, e-newsletters etc.

Aghios Nikolaos is the capital of Lasithi, the 4th prefecture of Crete at the eastern part of the island. Aghios Nikolaos marina is situated next to the main harbor of the city.

On 2004 the marina was awarded with a "Blue Flag" meeting 22 environmental, organisational and safety criteria. The total capacity of the marina is 255 berths while there are dry docking facilities for approximately 100 boats. Moorings are available for boats up to 50 meters long and 8 meters draught. All berths provide fresh water and 220/380 volt electricity.

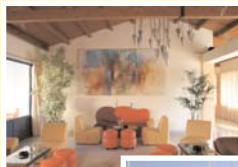

2. Guidelines concerning new tax regulations

Following the great interest, expressed mainly by foreign yacht owners, on the recent regulation of the Treasury and taking into account several articles and letters which came up, K&G looked at this matter and made a lot of contacts with the responsible people of different authorities.

In this respect, in accordance with the current legislation, the following clarification is provided :

1. There is no new tax law. The recent regulation (P 02 1091/14.06.2005) provides guidelines for the implementation of old laws, applicable to all EU countries, regarding the import of a yacht in an EU territory.
2. The regulation concerns **ONLY** yachts that are flying a non - EU flag and for which a transit log of unlimited validity has been issued by the Custom Authorities (the yacht has been imported in Greece).
3. The regulation **does not** concern any foreign owners of a yacht flying an EU flag or yachts sailing in Greek waters for tourism purposes.
4. All Vessels flying non EU flags, can stay in Greek marinas for wintering up to one year.



3. Opening of Ianos Hotel in Lefkas Marina



A brand new 3-Star Hotel has opened in Lefkas Marina. The hotel operates all year round and has 22 rooms, all equipped with central air conditioning, tv and mini bar. The hotel amenities include a swimming pool, free parking, 24-hours room service and breakfast.
